NOTIFICATION OF DOCKET ENTRY

This docket entry was made by the Clerk on Friday, June 24, 2022:

MINUTE entry before the Honorable Young B. Kim: According to Lenders' Objections, there are 28 so-called "Single-Claim Properties." (See R. 1210 at 21-22.) Comparing the addresses included in Lenders' Objections at footnote No. 14 with the addresses and the names of the claimants in Exhibit 5 referenced in their Objections, (R. 624-1), Claimant Midland Loan Services, a Division of PNC Bank, N.A. as servicer for Colony American Finance 2015-1 has an interest in 24 such Single-Claim Properties---Property Nos. 16-21, 23-25, 27, 29-32, 34, 36-39, 41-44, and 48. Claimant Midland Loan Services, a Division of PNC Bank, N.A. as servicer for Wilmington Trust, N.A., as Trustee for the Benefit of Corevest American Finance 2017-1 Trust Mortgage Pass-Through Certificates has an interest in two Single-Claim Properties---Property Nos. 45 and 46. Claimant U.S. Bank National Association ("U.S. Bank"), as Trustee for the Registered Holders of J.P. Morgan Chase Commercial Mortgage Securities Corp., Multifamily Mortgage Pass-Through Certificates, Series 2018-SBS0 has an interest in one Single-Claim Property---Property No. 66. As to the last remaining Single-Claim Property identified in the footnote as being located at "6749-59 S Merrill Avenue," the court is unable to identify the individual or entity claiming an interest. The appropriate Lenders are to file a status report by June 29, 2022, confirming the accuracy of this order and identifying the "Sole Claimant" for the property located at "6749-59 S Merrill Avenue." A hearing on the Receiver's fee allocation motion as it pertains to U.S. Bank and Property No. 66 is scheduled for July 5, 2022, at 10:00 a.m. in courtroom 1019. The court orders the Receiver and U.S. Bank to appear at the hearing. They must allow at least two hours for this hearing. The court will not hear arguments from any other party. Mailed notice (ec)
